DOES THE SCHOOL DISTRICT HAVE YOUR UP-TO-DATE CONTACT INFORMATION?

As the new school year approaches, make sure Pinellas County Schools has your current phone number and email address.

The district needs accurate contact information to call and email parents about:

- Emergencies or severe weather.
- School or district events.
- Special application opportunities.

To update your phone and email address:

1. Visit <https://reservation.pcsb.org> and log in with your parent username and password. If you do not have a parent ID or forgot yours, you can get help at any public school. Make sure to present a valid photo ID.
2. Select the option: "Change Phone and Email Address Only"
3. Enter your child's name and date of birth or student ID number, and update your phone number and email address.

Remember: Updating the emergency contact card or clinic card at your child's school does not update your contact information in the system used for automated phone calls and emails.

APPLY FOR SCHOOL LUNCH

Students may qualify for free or reduced-price meals. One family application must be submitted each year listing every child in the household. Paper applications are available throughout the school year from your school, or you may use the convenient online application: MySchoolApps is a quick and easy way for parents and guardians to submit application for benefits. This service is provided to you free of charge by your School District. <https://www.applyforlunch.com/>

MEAL ACCOUNTS

Paid and Reduced School Lunches can be prepaid by cash or check only, and put into your child's account in the cafeteria. Checks should be made payable to (name of school) Food Service (i.e.: Largo High School Food Service). The money remains in the student's account, and rolls over from year to year. Your student's account may be replenished at any time during the school year to avoid a negative balance.

MY SCHOOL BUCKS - ONLINE SERVICE

My School Bucks is an online payment portal specially designed to allow parents to make convenient, anytime payments to their children's school meal accounts. Create a new account with My School Bucks using the student's 10 digit local ID number. You can find this number in Focus, which is located in the District's Home Page drop down menu; once in Focus, search under "Local Student ID". Each student will need his/her own account.

In General

The dress and grooming of District students shall be neat and clean, promoting a positive educational environment. Apparel that disrupts educational activities and processes of the school will result in the removal of the student from the regular school environment until acceptable apparel can be secured for the student. The administration will be the final judge about whether a student's clothing is appropriate for school or whether it will create an environmental climate that is distracting to learning. Principals, faculty, and staff members will enforce the dress code. Failure to comply with the dress code will be handled similarly to other disciplinary infractions. Non-compliance may result in consequences including but not limited to detention, in-school suspension and loss of eligibility to participate in extracurricular activities.

Pursuant to F.S. 1006.07, wearing clothing that exposes underwear or body parts in an indecent or vulgar manner or that disrupts the learning environment will have the following specific consequences. In addition to these consequences, the violation shall be corrected before the student is allowed back in the regular school environment:

Requirements for student dress in all schools are listed below:

- A. All shirts and blouses must cover midriff, back, sides, and all undergarments including bra straps at all times. All shirts, tops, and dresses shall have sleeves and cover the shoulders.
- B. Shorts, skirts, divided skirts, dresses and culottes are allowed. They must be mid-thigh length or longer.
- C. All trousers, pants, or shorts must totally cover undergarments, including boxer shorts.
- D. All clothing, jewelry, or tattoos shall be free of the following:

profanity; violent images, wording or suggestion; sexually suggestive phrases or images; gang related symbols; alcohol, tobacco, drugs or advertisements for such products.

- E. Safe and appropriate footwear must be worn. Inappropriate footwear includes, but is not limited to, roller skates, skate shoes, and bedroom slippers.

Further Clarification/Other Requirements:

- A. Form fitting leotard/spandex type clothing is not allowed unless proper outer garments cover to mid-thigh length or longer.
- B. See through or mesh fabric clothing may only be worn over clothing meeting requirements.
- C. Clothing must be appropriate size, with the waist of the garment worn at the student's waist.
- D. Clothing not properly buttoned, zipped, fastened, or with inappropriate holes or tears shall not be worn.
- E. Clothing and footwear traditionally designed as undergarments or sleepwear shall not be worn as outer garments.
- F. Sunglasses may not be worn inside unless a parent provides a doctor's note to the school.
- G. Bandanas or sweatbands are not allowed to be visible on school grounds during the regular school hours.
- H. Hats or other head coverings may be worn during outside P.E. activities and may not be worn during any portion of the regular school day without the expressed permission of the principal.
- I. If the school has a mandatory school uniform policy, the student must adhere to those requirements.

The Absolutely Free Student Checking account is designed for individual MIDFLORIDA members 10-20 years old. Depending on age, the account may require a parent or guardian's signature. Identification (school or government-issued ID) required to open account. Offer valid as of March 1, 2019 and may be canceled at any time without notice. A \$5 deposit is required for membership with MIDFLORIDA Credit Union and a minimum deposit of \$25 is required to open the Absolutely Free Student Checking account. 1. Promotion applies to new Absolutely Free Student Checking accounts. Anyone who has held a checking account with MIDFLORIDA in the past year will not qualify for the \$25 incentive. No dividends are paid on Absolutely Free Student Checking. Annual Percentage Yield is 0.00%. To receive the \$25 incentive, you must complete five debit card purchase transactions within the first 45 days. Once the qualifications have been met, \$25 will be deposited into the account on the 46th day and will be reported to the IRS. See associate for details regarding terms and fees. 2. Bonus Bucks are awarded only to members with Absolutely Free Student Checking accounts. To receive Bonus Bucks, you must complete 20 debit card purchase transactions over \$5 in a rolling 90-day period. Each time the qualifications are met, \$1 will be deposited into the account.

CELLULAR TELEPHONES, ELECTRONIC COMMUNICATION DEVICES, AND OTHER ELECTRONIC DEVICES

Parents are advised that the best way to get in touch with their child during the school day is by calling the child's school office.

Students may possess a cellular telephone, electronic communication device (ECD), or other electronic device, such as, but not limited to, the following: personal digital assistant (PDA), portable media player (PMP), iPod, iPad, Kindle, mp3 player, and other devices designed to receive and send an electronic signal, so long as they do so in strict compliance with this policy. Any student who fails to abide by the terms of this policy forfeits any right or privilege to possess any electronic device described in this policy.

Violations of this policy may result in disciplinary action and/or confiscation of the cellular telephone, ECD, or electronic device. If the cellular telephone, ECD, or electronic device is confiscated, it will be released/returned to a parent unless an alternative arrangement is agreed to by the principal (or designee).

- A student may possess a cellular telephone, electronic communication device (ECD), and other electronic devices in school, on school property, at school-related functions, provided these items are powered off and concealed from view while school is in session.
- Students may not use cellular telephones, other ECDs, or other electronic devices on school property or at a school-sponsored activity to access and/or view Internet web sites that are otherwise blocked to students at school.
- When directed by the administrator or sponsor, cellular telephones, ECDs, and other electronic devices shall be powered off, and concealed from view during school activities occurring outside the student day.

- Cellular telephones, ECDs, and other electronic devices are to be powered off, and concealed from view on district buses, except as authorized by the driver.
- The requirement that cellular telephones, ECDs, and other electronic devices must be powered off, and concealed from view will not apply when the student obtains prior approval from a school administrator.
- The use of cellular telephones, ECDs, and other electronic devices in locker rooms, classrooms, bathrooms, and/or swimming pools is prohibited.
- The student who brings a cellular telephone, ECD, or other electronic device to school does so at his/her own risk. The student who possesses a cellular telephone, ECD, or other electronic device is responsible for its care.
- Any cellular telephone, ECD, or other electronic device left behind on a district school bus will be retained at the respective bus compounds until retrieved either by the student or parent possessing proper identification.
- School Board staff is not responsible for preventing theft, loss, damage, or vandalism to cellular telephones, ECDs, or other electronic devices brought onto its property, or left on school buses, including any electronic device confiscated due to inappropriate use.

CODE OF CONDUCT

As part of opening day processes, every student received a copy of the Pinellas County Schools Code of Student Conduct, which outlines in detail many policies including disciplinary procedures such as consequences, explanation of due process, and the process for appeal of suspension. As a student in our school, you are expected to comply with the Student Code of Conduct at all times.

Students in honors, advanced placement, or magnet courses who are expelled or reassigned to a disciplinary school must be aware that their curriculum will be impacted. While every attempt is made to match schedules, it is rarely possible to replicate every class. Students taking these classes must be aware that, when engaging in serious code of student conduct violations, they are jeopardizing their academic plan.

SCHOOL PROPERTY

School facilities and equipment belong to our community and we must demonstrate pride and care in their use. Students who damage school property can expect that their parent/guardian will be notified of their actions and that they will be responsible for cleaning, repairing or replacing the damaged item(s).

COLLEGE VISITS

School Board policy states that students may have up to four absences for the purpose of college visits, beginning at the start of their junior year. Armed Forces and vocational school visitations will fall under this provision. The appropriate documentation must be completed in order to have the absence coded as a college visit. The College Visit Form can be obtained from Guidance, the ExCEL office and on the school web site. This form should be presented to your Assistant Principal for his/her approval in advance of the visit.

CLINIC CARD UPDATE

Assist us with updating our records. Take a few minutes to complete the clinic card your student brought home in the first few days of school.
